## MfS/17/12/05 Agenda

## MfS/17/12/06 Court and Prison Register

We receive two communications relevant to the court and prison register.

Ian Bray of Brighouse West Yorkshire AM was arrested in London on 30<sup>th</sup> October, as part of an action undertaken by 'Rising Up' to highlight air pollution in London. Along with three others, he was remanded in custody at HMP Thameside for eight days and has also been fined.

The case involving Barbara Penny of York Area Meeting (our minute MfS/15/12/06 refers) came to Leeds Crown Court on 17 August 2017 and the driver of the vehicle was acquitted. Minute 4 of York Area Meeting held on 9 September 2017 informs us further of Barbara's witness during the trial.

We agree to add the names of these Friends to our court and prison register, and we hold them in the Light.

## MfS/17/12/07 Concern about the poverty of the public services in the UK

We receive minute 07/2017/08 of Staffordshire AM held on 8 July 2017 regarding a concern about the poverty of public services in the UK.

#### MfS/17/12/08 For The Common Good

We receive minute 17.09.07 of Kendal & Sedbergh AM held on 17 September 2017 regarding the group 'For the Common Good' and Chris Bullard, from that area meeting, has told us more about the plans for the Ride of Witness 4 Equality and the Common Good in the summer of 2018, which will be passing through twelve Area Meetings. We hope that Friends will support this initiative where they are able.

## MfS/17/12/09 Investments profiting from the occupation of the West Bank

We receive minute 80/2017 of Devon AM asking BYM to consider adding to their current list of exclusions for investment purposes any company that is profiting from the occupation of the West Bank. We also receive minute 70.17 of Sussex East AM held on 14 October 2017 in support of Devon AM's minute.

We have heard from Trustees that our current investments do not include investment in any company with direct interests in the occupied Palestinian territories and that the BYM investment policy is currently under review.

We forward these minutes to BYM Trustees, QPSW Central Committee and Quaker Committee for Christian and Interfaith Relations.

## MfS/17/12/10 Payment of taxes for terrorism and war

We receive minute 68.17 of Sussex East AM held on 14 October 2017 regarding concern over the use of taxes in the UK to fund involvement in war.

We forward this minute to QPSW Central Committee, asking for advice.

## MfS/17/12/11 Church Government Advisory Group

We receive minutes CGAG 17/24 and CCAG 17/28 proposing amendments to the current Book of Christian Discipline of Britain Yearly Meeting (currently *Quaker faith & practice*).

Minute CGAG 17/24 proposes new text which takes account of the laying down of Six Weeks Meeting and the foundation of the London Quakers Property Trust (Qfp 5.09, 6.25, 7.01 and 7.04). Minute CGAG 17/28 proposes three changes to references to Data Protection (Qfp 8.21, 11.06 and 11.25):

- 8.21 Change the second to last paragraph to: The Recording Clerk is responsible for ensuring that the recording and processing of data held by the yearly meeting conforms with the law. (4.45)
- 11.06 and 11.25: change 'the Data Protection Act' to 'data protection legislation' in both cases.

We agree the proposed changes and forward them to Yearly Meeting.

# MfS/17/12/12 Revision of the Book of Discipline

Lesley Richards, Clerk to the Book of Discipline Revision Preparation Group, has spoken to a report from the Group recommending that the Yearly Meeting revises our Book of Discipline. The report lays out the reasons why the Book of Discipline Revision Preparation Group (BODRPG) is making this recommendation, and explores some of the recommendation's main implications. Several members of the Group are with us today and we have heard a summary of the work and the 'journey' that has been taken by the Group both individually and together. They have focussed on listening to Friends throughout the yearly meeting and have gathered feedback from many who followed the Reading *Qf&p* programme. They have been interested in 'how it has felt' and especially in the context of religious difference. General conclusions are that Friends find that the church government sections need revision, that we are listening more to each other in our expression of faith and that we feel more involved in the process of revision.

We feel that the time is right to start a revision of our book of discipline.

We also agree:

- 1) The revision should begin with, but not be limited to church government, namely the sections which focus on our procedures and corporate discipline.
- 2) The revision should divide material between that in the main body of the book, which lays out principles, and supplementary material, which gives details.
- 3) The revision should draw on the richness of theological thought in our yearly meeting, now and historically, seeing diversity as fundamental to our community, not as a flaw.
- 4) The Revision Committee be given the freedom to be creative, while remaining in close contact with the yearly meeting.

If the Yearly Meeting agrees the recommendation, Meeting for Sufferings will be ready to support the process. We have today considered the draft terms of reference prepared by the BODRPG that could support the Revision Committee, and we have shared some initial thoughts.

We rejoice that the work of the BODRPG has enriched Britain Yearly Meeting and enabled Friends to grow in their spiritual and theological understanding.

We thank the group for their work and for their report.

We forward this minute to Yearly Meeting and ask the BODRPG to work with YMAC in preparing materials.

## MfS/17/12/14 BYM Trustees report

We receive BYM Trustees' minutes of their meetings on 22-23 September and 17 November 2017 and note particularly BYMT 2017-11-11 (Transparency of Lobbying Act) and BYMT 2017-11-12 (Sustainability Strategy).

Ingrid Greenhow, clerk of BYM Trustees, has told us more about the business at the Trustees' meetings in September and November, and has updated MfS on the 2018 operational plan.

The plan is presented to us within the framework of Our Faith in the Future, and we are pleased to see the Trustees are drawing on the discernment of Meeting for Sufferings.

Peter Ullathorne (BYM Treasurer) has told us about the Operational Group Budget for 2018. In summary, we have done better in 2017 than forecast. In 2018 activities will continue as before, and we expect a deficit lower than in 2017.

We thank the Trustees for their reports.

### MfS/17/12/15 Sanctuary Everywhere Manifesto

Further to minute MfS 2017/10/17, we receive minute QPSWCC 2017/19, with a redrafted Sanctuary Everywhere Manifesto.

The introduction to the revised manifesto places it firmly within the Quaker tradition of seeking that of God in everyone, speaking up for the oppressed and speaking out against 'all acts of Government which set people against one another and turn away those in need'. The manifesto is framed in the context of Quakers' longstanding work of welcoming newcomers to our shores.

With some amendments, we approve the manifesto as follows:

As Quakers, we have long worked for peace and equality, because of our belief that there is that of God in everyone, everywhere, whoever they are.

Through Quakers' longstanding work welcoming newcomers to our shores, we have seen up close that the government's creation of a 'hostile environment' is increasingly embedding policies of discrimination into the practices of the British state. Quakers in Britain are committed to working with others to change this, creating a culture of compassion and welcoming hospitality that answers that of God in every person.

Our Meeting for Sufferings was born of a response to the government's systematic discrimination against Quakers in the past. Today we turn that experience into solidarity,

and stand against all oppression and suffering. We declare our determination to work for sanctuary everywhere, including here in Britain, by agreeing this Manifesto for change.

- Human rights standards for all should be the foundation on which any national policy or international agreement on migration is founded, and these include the right to work, to learn, to housing, to medical care and to security in the event of adverse circumstances beyond personal control.
- We will campaign for change to the asylum process so that it is built on a culture of compassion and practical response, rather than starting from an assumption of disbelief.
- Within the UK system of immigration detention is institutional violence and discrimination. We oppose indefinite detention, which we believe neither right nor necessary, and will work towards the closure of all detention centres. Other more humane policies are more effective and should be introduced.
- Our belief in every human being's equality leads us to oppose unjust deportations and removals, whether to the EU or to the wider world.
- The humanitarian risks of trafficking and unsafe passage lead us to work for new, peaceful, safer routes of migration including the introduction of humanitarian visas and improved rules for family reunion.
- To ourselves and wider society, we reaffirm our determination to acknowledge and dismantle discrimination in all of its forms, wherever it is to be found.

We thank QPSW staff and its Forced Migration Advisory Group for their work.

## MfS/17/12/16 Meeting of Friends in Wales

Gethin Evans introduced the report from Meeting of Friends in Wales.

#### The report began:

Wrth i mi gyflwyno'r adroddiad yma sylweddolwn mai dyma'r gyntaf o'i math ac felly yn ddatblygiad pwysig ym mywyd Cyfarfod Blynyddol Prydain ac efallai fod hyn hefyd yn arwydd o wendid sef na fu i'r Cyfarfod Blynyddol roi digon o sylw i Gymru yn y gorffenol.

(Introducing here the first report from MFW to Meeting for Sufferings seems an important development in the life of BYM, a pointer, perhaps, to Yearly Meeting having given insufficient attention to Wales in the past.)

2017 marks the first 25 years of Meeting of Friends in Wales (MFW), and there has been considerable change over this period, particularly as a result of devolution. MFW fosters links with relevant groups including CYTÛN (Churches Together in Wales) – Friends are represented on its Board of Trustees and Board of Finance - and an MFW representative is appointed to the group of denominational church and society policy officers that monitors the Assembly's work. The membership of MFW includes all Quakers who live or worship in Wales, thus crossing Wales' borders. MFW is seeking provision for a tabular statement for Wales itself, to make the situation clearer.

With increased funding the Meeting has been able to extend the administrator's working hours and also to cover the additional costs of simultaneous translation in meetings. Creating parity for English and Welsh speakers within meetings and for the purposes of inreach and outreach is an important element in MFW's work.

The report draws our attention to the Spiritual Hospitality report published in 2003.

In Wales Friends' witness includes gatherings for spiritual nurture, publications in Welsh and English for wide use, and outreach via events such as the National Eisteddfod, the Royal Welsh Show and, more recently, the Hay Literature Festival.

We welcome this report and all the work it represents, and thank Gethin for introducing it.

## MfS/17/12/17 General Meeting for Scotland

Adwoa Bittle, clerk of General Meeting for Scotland, spoke to us about General Meeting for Scotland.

There are approximately 1500 Quaker worshippers in Scotland, about half of whom are in membership. With such a wide geographic spread, from Shetland to the Borders, community building across all ages is very important.

General Meeting for Scotland meets four times a year, and there are activities for young people such as Shindig. It is a challenge to participate in some Yearly Meeting events when summer school holidays only overlap by a maximum of 10-14 days.

We have heard about two different strands of parliamentary engagement and also about ecumenical links.

We thank Adwoa for her lively report.

Members of the Young People's Participation day held alongside Meeting for Sufferings have joined us for closing worship. We have shared news about each other's agenda. We are pleased to have this opportunity for inter-generational dialogue and worship together. We thank them for their participation. We receive the report on their day's activities as follows:

At the Young Quaker Participation Day 2017 alongside Meeting for Sufferings, we had the opportunity to learn about the Quaker decision making process. In the morning some chose to do a variety of activities relating to the book 'Living our Beliefs' while others chose to attend the Meeting for Sufferings session on the Book of Discipline Revision Preparation Group report. Participants felt this opportunity allowed us to have an involvement in Quaker decisions. Many felt this was empowering, although some thought it was difficult to find the confidence necessary to participate in a large meeting. However, one participant said it was great that 'in a room with a hundred people, everyone had a voice'; and even those who would not fully identify themselves as a Quaker found it 'informative, welcoming, and surprisingly fun'. It was also a reminder that young Quakers are not a separate group but part of a wider body.

At lunch, we appreciated the opportunity to meet our Area Meeting representatives for Meeting for Sufferings and discuss Quakerism with them. It was interesting to speak to these slightly older Quakers who we may never have met before. We enjoyed being able to hear about their experiences and get a different perspective on Quakerism. Participants also enjoyed the opportunity throughout the event to meet both new people and old friends.

The afternoon brought more choices with the chance to re-join Meeting for Sufferings during their session on the 'Sanctuary Everywhere Manifesto' while the rest of us continued enjoying activities on 'Living our Beliefs'. The overall opinion about the event was certainly positive. We would like to continue being involved in the discernment regarding the revision of the Book of Discipline, and hope that this can be arranged.
